I understand that by signing below, I forfeit all rights and claims against UBTT, its owner(s), organizers, sponsors, participants, promoters, the organization officials, shareholders, officers, directors, employees and all other entities or persons associated with UBTT tournaments and related events.

By signing this Waiver and Release form, I am stating that I have read and I understand and agree to be bound by all rules for this event. I understand and agree that it is not the responsibility of any individual, including the tournament director, sponsors, or tournament organizers to provide assistance for on-the-water repairs or rescues at any time. Each contestant shall be responsible for his or her own communication devices and on-the-water assistance. The owner(s), tournament director, tournament organizers and sponsors are not responsible for assuring that any or all contestants have returned at the end of the event.

I agree to provide insurance for health, liability and accident to cover any damage or injury, including, but not limited to, property or bodily damage, incurred by others or myself as a result of my participation in any UBTT tournament or event.
